No entry fees will be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Show Committee. Entries will not be refunded for bitches that come into season after entries close.

Refund for bitches in season. The club will refund the entry fees minus a \$10 processing fee for bitches entered in Obedience or Rally that come in season after the closing date of these trials. Refunds may be obtained by providing a veterinarian's certificate to the trial secretary no later than 30 minutes before the start of the trial.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, dangerous weather conditions, Acts of God, public emergency, act of public enemy, strikes, or any other cause beyond the control of the club. No entry shall be made or accepted which specifies any condition as to its acceptance, and will not be accepted without fees or signatures. Changes, additions, or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

From the South:

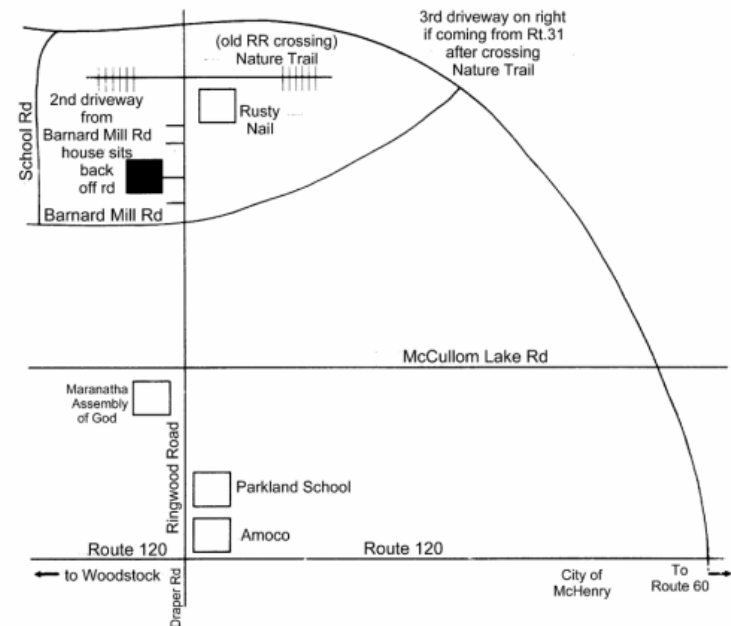
North on Route 31, left on Ringwood Road (watch for overhead stoplight). 1 block to entrance.
